BOARD BRIEFS

GATES – JUST SO YOU KNOW—During the first part of July the gates were out of order and locked in the up position. The power supply to the scanner on the ingoing gate was damaged during a thunderstorm and had to be replaced. The outgoing gate was hit by a vehicle and both the gate and the bracket were damaged. The gate arm and bracket have been repaired and as of this writing we are awaiting the installation of a new power supply. We understand that when the gates are not functioning they are not keeping non-resident traffic out, but the more important issue is that emergency vehicles must be able to enter and exit without delay, so we locked the gates in the “up” position until they are repaired and fully functional.

COMMON PROPERTY—Myrtle Trace was built on the concept of common property. Any property not included in the individual homeowner’s survey or plat map is common property and is maintained by the Association for the use and enjoyment of the entire community. The Board, with the help of the Property Committee and Hardee Maintenance, is charged with the maintenance and preservation of the common property including the Clubhouse, the pool, wooded areas, ponds, roads and the common ground around individual residences, such as the 10 feet of grass between the edge of the road and our deeded property lines. As we discussed in earlier issues of News & Views, since we have no central irrigation in Myrtle Trace, the individual homeowners are responsible for the irrigation of the common property adjoining their deeded lot.

WHAT IS THE COMMON PROPERTY MAINTENANCE AGREEMENT—Over the years some residents have expressed a desire to maintain the grassy common property adjoining their deeded lot. Those homeowners may apply to the Board for a **Common Property Maintenance Agreement**. Since care and maintenance of the common property is essential to the value of our individual properties and the appearance of Myrtle Trace, the agreement specifies strict guidelines for the maintenance of that common property including regular mowing, fertilizing, insect control and sod replacement. Applications for the maintenance agreement are only considered twice a year in March and September. The application form is available at the Clubhouse and should be submitted to the Board in September. After consideration by the Board a letter will be sent to those homeowners who choose to apply. The agreement is not effective until the letter of acceptance by the Board is received by the homeowner. The Association reserves the right to cancel the Agreement if requirements are not met. The homeowner may also cancel an approved Agreement but re-application is not accepted. Further, the Agreement is with the homeowner and does not continue when the property is sold. (See the Property Committee report for further details.)

BOARD ACTION TO BE TAKEN—Both the Board and our Committees are constantly reviewing our Covenants and Guidelines to make sure that they are in agreement and serving the purpose for which they were intended. We currently have a policy on **“Planting on Common Ground Around Mailboxes”**. This Board believes that the reflectors on the mailbox posts are vital to the safety of our residents and to the protection of the posts. Therefore, we propose to add “reflectors” to section 1 of the policy which will read as follows: “Homeowners may plant vegetation around the base of the mailbox. Any vegetation planted must be maintained and trimmed to a height which enables the mailbox, paper box, address number and the reflectors on the mailbox post to be clearly visible.” The remainder of the policy will remain unchanged. We will entertain discussion and vote on the proposed change at the August Board meeting.

- **MANY THANKS:** The Property Committee wishes to thank Bill Alexandra (a retired electrician) for always lending a hand to our staff when we need electrical guidance or help. Our thanks to Dave Atkins who spearheaded the Tree Committee. Dave has just resigned from the Tree Committee. He and his team did research on which trees and shrubs should be planted in Myrtle Trace, replacing those which have fallen down or aged out. Ellen Elliot, who was on the team, will now take the lead. The Property Committee welcomes and thanks Ellen Elliott.
- **HOMEOWNER FORMS:** Forms to apply this September for Homeowner Maintenance are available in the Clubhouse to the left of the telephone in a hanging bin. They are to be filled out, signed and returned no later than Sept. 30th and placed in the MTHOA slot at the Clubhouse. For detailed information, please read the Board Briefs.
- **LIGHT POLE AT THE CLUBHOUSE:** The light pole opposite our Clubhouse is being hit by vehicles while parking. Santee Cooper has fixed the leaning light pole twice. To make the pole more visible, we have painted concrete barriers in front of the pole yellow. Please be careful when parking.
- **NAMED STORMS:** After a named storm, residents have 4 days to place fallen limbs on HOA grass for pick-up by the Hardee crew who have 4 days to pick up the debris. All other times, it is up to the individual resident to discard their waste and tree limbs. Please do not blow debris into the road.
- **POOL:** We are happily seeing an attendance of over 800 people each month.
- **ROADS:** When bicycling and coming from side streets onto Myrtle Trace Drive, please slow down to ensure that a motorist has seen you coming. An incident occurred recently when a resident driving a car narrowly missed a person on a bike due to the wide turn and speed the cyclist was traveling. The motorist was shaken and had to pull over to the side of the road for a while. We all enjoy our roads and it is up to all of us to keep each other safe.

TREASURER'S REPORT Budget Report First Half FY 2023

The first half of the fiscal year has been completed. Time marches on.

The first half revenue was 100.6% of plan and operating expenses were 95.3%. A combination of accurate budget projections and careful expense management contributed to this positive performance. Most major expense categories showed a surplus when compared to budget.

Myrtle Trace reserve funds total \$540,194 and are held in accounts with 4 local banks. The funds are held in checking accounts and certificates of deposit. Reserve fund account balances are reviewed monthly to make sure that we comply with the FDIC regulations for insured deposits. Myrtle Trace's financial position remains strong.

BOARD ACTION TAKEN—The Property Committee and our Lake Management Company are constantly monitoring the condition of our ponds. This time of year we keep the water level low so the retention ponds can handle the heavy rains during the hurricane season, and the outflow pipes must be kept free of debris and silt. Just after our last meeting we received a proposal from Total Lake Care to manually extract debris and silt from Oriole and Quail and to haul the harvested material offsite. In order to accomplish this and service Oriole properly we had to build a stone ramp to allow boat access. The only common ground available was between 103 and 105 Hickory Lane. Since this is an important part of hurricane and storm preparedness, the vote to approve was done electronically so work could begin as quickly as possible.

WILDLIFE IN MYRTLE TRACE—In past issues of News and Views we've discussed a number of wild-life issues in our community, including bears, foxes, coyotes, beavers and geese and we've shared information from the Department of Natural Resources with the community. Since we had a recent incident where geese were killed, a number of residents contacted the Board and the DNR for further clarification and to report the incident. The Department of Natural Resources website states that "No federal or state permit is required to scare or herd geese **as long as no birds are physically harmed or killed**. Some dispersal techniques include noise-making devices and chemical repellent." Should you see an incident where wildlife is harmed, call the ***Department of Natural Resources law enforcement division at 1-800-922-5431**. **Any time you hear shots fired, contact the *local police at 843-248-1520**. Many of us enjoy the wildlife around us and some consider it a nuisance but we must all abide by the law and consider the safety and comfort of our neighbors.

COMPUTER AND PHONE SAFETY—We are all potential victims of computer hacking, spam messages, and those phone calls asking for money for grandchildren or friends in need. Some of our residents have received requests for money supposedly from fellow residents who are listed on our website. Be assured that no one on your Board or any of your committees will call you asking for money "for a good cause". On July 20th we were fortunate to have the Horry County Police Department present a program on mail theft (don't put outgoing mail in drop boxes – take it into the post office – the drop boxes are broken into regularly); phone scams (never say "yes" to an unknown or unidentified caller); and computer scams (never open a link you are not familiar with). More importantly, if you are a victim of a scam or suspect that you have been, file a report by calling the non-emergency police number (843-248-1520) or you can go online to Coplogic to file a report. The officer who made the presentation is Kathy Thompson, Horry County Detective, who can be reached at 843-915-7999 and is willing to answer questions.

HOMEOWNERS INSURANCE—The Association must keep a record of insurance on all the property in Myrtle Trace. If you haven't already done so, please send Debi Perry, our Administrative Consultant, information about your homeowner's insurance whenever your policy renews. We need your name, address, insurance company, policy number and expiration date. Jeanne Bredbeck – 244 Candlewood Drive

Jeanne and Bill moved to Myrtle Trace from Ohio in 1995. They were looking to get away from the snow back home and since Bill liked to travel they saw all 50 states and several provinces and countries. While traveling, they checked out Washington and Oregon for retirement but Jeanne ruled it out as it rained every day until noon. Bill was a retired chemist who focused on air and water pollution. Jeanne had been an elementary school teacher. Bill had read an article in a financial magazine about Myrtle Trace so they came to look at it and the set-up appealed to them. Bill fell in love with Myrtle Trace. Jeanne liked the seclusion and the trees. The fact that there was a hospital and an airport close by were favorable things, as well, and they found the people to be very friendly.

They came to look at Myrtle Trace on Easter vacation and by July of that same year their house had been built and they had moved in. At that time, Phase VIII only consisted of Candlewood and Beechwood and Loblolly was just being built. Their house was one of the first twelve houses to be done. Glenwood Drive had not been cleared yet. Because all of the homes on Candlewood were being built at the same time, they formed golf groups and a dinner group primarily of people from Phase VIII. Jeanne and Bill started an annual block party. Bill joined the Lakes Committee and they were both on the Activities Committee for three years. Jeanne delivered the “News and Views” for twelve years. Jeanne said one of the best things about Myrtle Trace is our fantastic Board of Directors. She said they can do more with less contention than any other group she has seen.

Joseph and Joanne Martin – 106 Laurelwood Lane

Joe and Joanne moved to Myrtle Trace from Westchester, New York. They first vacationed in North Myrtle Beach and would visit neighbors from home that lived in Myrtle Trace. They began looking into living here in 1995 when there were only three properties available. The fact that the lot they chose had a brand new Titleist golf ball in the yard sealed the deal! They began building in 1997 before Joe retired. They liked the area because the developer, Glen Hall, had not taken down every tree and removed the topsoil, therefore maintaining the integrity of the area. They were introduced to Tom Allen, the architect, and with him they redesigned the entire inside of the house.
